**If filed after January 31<sup>st</sup>, a late fee of \$25 will be assessed.**

**NO** person or company shall operate a business after January 31<sup>st</sup> without a license. Violators will be prosecuted.

An approved license must be posted on your premises at all times. You **must** complete and obtain a business license if you operate a business in any capacity within the Village of Geneva on the Lake, including but not limited to: restaurants, bars, any retail operation, hotel, lodging and rentals whether on a daily, weekly, monthly or an annual basis. A separate license is required for each business, and must be accompanied by a separate fee of \$100.00. **All** applicable forms **must** be completed and submitted prior to approval of the license application.
