**Transient Vendors Permit**  
Ordinance 2007-26

**This permit is to be used by all persons seeking to sell goods, amusements, food, beverages or other items from structures other than buildings permanently attached to the ground. Those seeking to sell from buildings permanently attached to the ground are required to complete and obtain a Village business license.**

- 1) I have read and agree to comply with Ordinances 2007-26 and 2007-25. The applicant and the landowner from whom sales are to be conducted are not delinquent in any village tax and the landowner possesses a valid business license.
- 2) All structures used in the sale must be clean and in good order and repair, without physical defects such as dents, broken or missing parts, chipped or peeling paint, rust, or any other features which would create an eyesore or present risk to persons or property.
- 3) The structures will not be moved from the area described in the application or onto public rights of way, and will not degrade the appearance of the surrounding area.
- 4) There must be at least 10 feet between any temporary structures or any other structure or building; the structure shall be at least 20 feet from any right of way or sidewalk and at least 10 feet from any property line and 50 feet from any residential unit on adjacent property, unless the required setback is greater, in which all setbacks shall be followed.

The applicant understands and agrees that the permit can be revoked at any time if the applicant, business, or owner violates any of these conditions and upon failure of the applicant, business, or owner to remove the offending structures, the Village is given implicit authority to remove the offending structures at the owner's expense and risk.
