Jeremy Shafer provided his Administrator Report for Council's review.

- Lake Erie water level is up 3 inches
- He talked to the EPA about a future water plant. They have only approved two new plants in Ohio in the past 10 years.
- Talked to Ed Spoor about the water lines in Geneva on the Lake. 85% are new. South Geneva was updated. They need to set up a meeting with Doug Starkey about Palmetto.
- Eastgate is stuck on streetscape as Downtown Revitalization. They might send a letter to the people on the strip but this is due in January.
- They have applied for \$8,082,627.55 in grants in 2023.
- 2 BZA appeals this year
- 76 zoning permits in 2023 last year 68
- 5 conditional use
- There is a Planning meeting in October 26<sup>th</sup> for the subdivision at 5533 Lake Road tabled
- 32 Code Enforcement cases in 2023
- They are working on a new IT contract. There have been issues with NEOTHINK and they think it is

better to get a dedicated person for the IT needs.

- Working with Brown and Vance on a project through the State Budget.
- Joyce is moving forward with the trunkline \$3 million request
- Siphon project is out to bid

Woodward asked where the Vencill fund stands. There was a discussion about funding trails out of the budget. Jeremey stated they are talking about putting a plaque on the shelter.

There was discussion about creating R&R accounts to funds projects.
